C€ Marking – The Gateway to Europe

Adopted in 1985, the CE (Conformité Européenne) mark is a European certification mark indicating that a product complies with the essential European health, safety, and environmental requirements set out in the European directives. Since the CE mark was developed, products no longer need to adapt to the specific requirements of the different member states of the European Economic Area (EEA). The CE mark provides assurance to all EEA countries that a product is safe. Determining whether your product requires this mark is vital for manufacturers who export products throughout the 27+ countries of the EEA.

In order to obtain the CE mark, a product needs to be assessed according to EU regulations, and must pass the relevant product tests (as guided by the directives and the related standards) in order to ensure that it is safe for consumer use.

Whether you are a large company developing new products, or a smaller organization ready to expand your market share, becoming familiar with the applicable EU directives for your unique product and understanding the CE marking process is crucial for tapping the vast potential of the European Union market.

Is My Product Considered Pressure Equipment?

The Pressure Equipment directive (97/23/EC – also known as PED) and the related directive – Simple Pressure Vessels (87/404/EEC), refer to a large group of products, which must be assessed properly to determine how best to apply the regulations.

"The directive concerns items such as vessels, pressurized storage containers, heat exchangers, steam generators, boilers, industrial piping, safety devices and pressure accessories. Such pressure equipment is widely used in the process industries (oil & gas, chemical, pharmaceutical, plastics and rubber and the food and beverage industry), high temperature process industry (glass, paper and board), energy production and in the supply of utilities, heating, air conditioning and gas storage and transportation."

The PED directive also indicates when the welders and welds need to have additional certifications (such as WPS and WPQR) in order to achieve the CE marking.
